## PLAN COMMISSION ORDER NO. 1-2019

ORDER OF THE CITY OF WASHINGTON PLAN COMMISSION (I) DETERMINING THAT A DECLARATORY RESOLUTION AND AMENDMENT TO THE ECONOMIC DEVELOPMENT PLANS FOR THE SOUTHEAST ECONOMIC DEVELOPMENT AREA, THE SOUTHWEST ECONOMIC DEVELOPMENT AREA AND THE I-69 CORRIDOR ECONOMIC DEVELOPMENT AREA, AS APPROVED AND ADOPTED BY THE CITY OF WASHINGTON REDEVELOPMENT COMMISSION CONFORM TO THE PLAN OF DEVELOPMENT FOR THE CITY OF WASHINGTON AND (II) APPROVING THAT RESOLUTION AND AMENDMENT TO THE ECONOMIC DEVELOPMENT PLANS

WHEREAS, on March 11, 2019, the City of Washington Redevelopment Commission ("Redevelopment Commission") adopted a declaratory resolution (the "Declaratory Resolution") pursuant to Indiana Code 36-7-14 and Indiana Code 36-7-25, and all acts supplemental and amendatory thereto (collectively, the "Act"), amending the declaratory resolutions and economic development plans previously approved by the Redevelopment Commission relating to the Southeast Economic Development Area, the Southwest Economic Development Area and the I-69 Corridor Economic Development Area (collectively, the "Original Declaratory Resolutions" and the "Plans", respectively) by adding as an additional project to the Original Declaratory Resolutions and Plans the planning, designing and construction of road improvements to Business 50 and all other related improvements, including utility and sidewalk improvements in connection therewith, in connection with the City's agreement with the Indiana Department of Transportation ("INDOT") for the relinquishment of Business 50 by INDOT to the City (the "Project"); and

WHEREAS, the City of Washington Plan Commission (the "Plan Commission") is the body charged with the duty of developing a general plan of development for the City; and

WHEREAS, the Act requires the Plan Commission to find that the Plans as amended by the Declaratory Resolution to include the Project conform to the plan of development for the City and to approve the Declaratory Resolution and the amendment to the Plans; and

WHEREAS, the Plan Commission has reviewed the Declaratory Resolution, the amendment to the Plans to add the Project, and the potential development contemplated thereby and determined that they conform to the plan of development for the City, and now desires to approve the Declaratory Resolution and the amendment to the Plans to include the Project;

NOW, THEREFORE, BE IT ORDAINED by the Plan Commission, as follows:

Section 1. The Declaratory Resolution and amendment to the Plans to include the Project conform to the plan of development for the City.

The Plans, as amended to include the Project, and the Declaratory Section 2. Resolution are in all respects approved, ratified and confirmed.

The Secretary of the Plan Commission is hereby directed to file a Section 3. copy of the Declaratory Resolution and the Plans, as amended to include the Project, with the permanent minutes
