Case W-6-21: Springs Valley Bank is requesting a waiver. The waiver would allow a 240 TSF that exceeds the 150 TSF standard to be erected on their property. The property is located at the 1717 S State Road 57 Suite H. Parcel number is 14-13-03-300-010.000-016. It is zoned C-4, Commercial Roadside Business. John DeVries, salesman for Custom Signs, represented Springs Valley Bank. He explained where they would like to place the sign. Board Member David Dahl asked about if the placement of the sign would be too close to the utility pole? Mr. DeVries said there was no issue. Without any other questions President Bill Summers requested that the secretary, Maria Sergesketter, take a roll call vote. Case W-17-21: Roger & Sandra Hand are requesting waivers. 1. Total Square Footage (3840 TSF) 2. Sidewall height (14'). 3. Accessory Structure on a R-2 zoned parcel without a primary residence. 4. Peak height possibly. The property is located at the 642 E 150 S. Parcel number is 14-13-02-100-013.000-016. It is zoned R-2 Residential Two-Family. Roger Hand was present at the meeting. He explained that this building would be for personal use. He wants to have more storage space and also potentially have space for a camper if he chooses to buy one. Doors would be 14' tall. It would be a two-tone wainscoting material.
