3	Fee of \$100.00 made out to The City of Washington.		
4	The applicant is requested to notify the adjoining property owners of the intentions for the property. Easiest way is by certified registered mail.		
5	The rezoning application will go before the City Plan Commission. The Plan Commission meets the second Wednesday of the month. The application must be turned in at least three three (3) weeks prior to the meeting.		
6	The rezoning application will also go before the City Council two (2) times. The Council meets on the second and fourth Mondays of the month.
