The following defines each Column:

Owner ID: This column is an Owner ID field created for this table only. This ID is not used anywhere else by the City of Washington. This ID was created for convenience in organizing and referencing this table, and serves no other purpose. This ID is not permanent and not associated with any other City data.

Owner Name: The owner name listed in county data for each following parcel

Parcel Number: The parcel number of each parcel owned

Impervious Area: The total impervious area (i.e. concrete, asphalt, structures) in square feet for each parcel or contiguous parcel grouping, calculated manually using aerial imagery from 2015 at 4 inch resolution

# ERU's: The number of *Equivalent Residential Units (ERU's)* for the listed Impervious Area (1 ERU = 2,558 sq. ft.)

Fee: The fee at \$4.25 per ERU for each parcel or contiguous parcel grouping billed monthly

ERU Based Bill: The Stormwater Fee for each Bill based solely on \$4.25 per ERU

ERU Based Total: The Total Stormwater Fee per Owner based solely on ERU Calculations

\$75 Max per Grouping Bill: The Stormwater Fee for each Bill based on \$4.25 per ERU with a maximum bill of \$75 per contiguous parcel grouping (parcels that are touching and not separated by a public right-of-way or other real property)

\$75 Max per Grouping Total: The Total Stormwater Fee per Owner based on a \$75 maximum bill per contiguous parcel grouping
